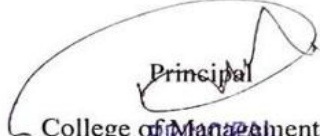

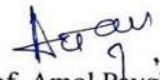

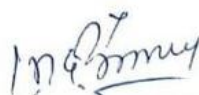
Upon arrival, the students were warmly received by the faculty of CMCS College. Prof. Gawarshettiwar, along with Ms. Akshata Ambidwar, Mr. Gulab Ingle, and Ms. Isha Meshram, conducted interactive sessions demonstrating the utility of various AI-based tools. The session began with an introduction to **ChatGPT**, highlighting its role in generating ideas, improving writing skills, and assisting in research. This was followed by a demonstration of **Perplexity**, an AI-driven search engine designed for accurate and reliable information retrieval.

The faculty also introduced **Google Gemini**, explaining its multimodal features and its growing significance in integrating text, images, and problem-solving techniques. Additionally, the application **Blackbox** was showcased, particularly useful for coding, debugging, and enhancing problem-solving efficiency in technical fields.

The students actively participated by asking questions and experimenting with the applications in real time. The session emphasized how these AI tools can enhance creativity, critical thinking, and efficiency in academic writing, language learning, and interdisciplinary studies.

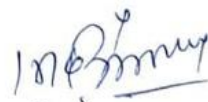
