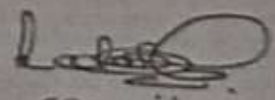

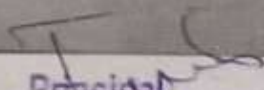

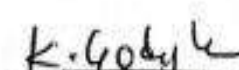
District Level Aavishkar Competition-2025

Executive Summary

Recent archaeological excavations at Pachkhed, located in the Babhulgaon Taluka of



Yavatmal district, have unveiled a continuous historical timeline dating back approximately 3,000 years. While the region is traditionally known for the history of the Gonds, Mughals, Nizams, and Bhosales, this new research provides concrete evidence of much older civilizations, specifically from the Iron Age, Mesolithic Period, and the Satavahana Era.

Key Findings

The research, initially highlighted by Dr. Vilas Wahane in 2009 and currently led by experts from Nagpur University, has yielded significant artifacts:

Industrial Evidence: Discovery of iron-smelting furnaces (kilns) and ancient pottery.

Architecture: Remains of Iron Age dwellings and brick wells from the early historical period.

Civilization Layers: Evidence of a transition from the Stone Age to a structured urban society.



Conclusion

The findings at Pachkhed are pivotal for understanding the cultural sequence of Vidarbha. This research successfully establishes that Yavatmal possesses a sophisticated human

settlement history reaching back to the Iron Age, contributing a vital chapter to India's ancient heritage.

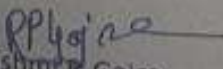


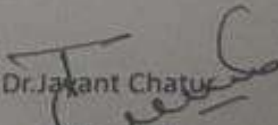
